**Subject: Update on Direction for closure of the factory / unit of the Company situated at Village Nara, Meerut Road, Muzaffarnagar, Uttar Pradesh.**

1. This is in continuation to our intimation dated May 29, 2025, regarding the direction from the Commission for Air Quality Management in National Capital Region Adjoining Areas, New Delhi ("Commission"), to close down all industrial operations /activities for the factory / unit of the Company situated at **Village Nara, Meerut Road, Muzaffarnagar, Uttar Pradesh ("Unit")**, until further orders for resumption.
2. In this regard, we would like to give an update that National Green Tribunal, New Delhi ("Tribunal"), vide its order dated May 30, 2025 (Copy received today, i.e., June 02, 2025), has granted permission to resume operations at the Unit, subject to compliance with the provisions outlined in the Tribunal's order.
3. Accordingly, the Company will submit a detailed reply to the Commission. After reviewing the submission and providing an opportunity for a hearing, the Commission will issue a fresh order in this matter.
4. Any further update on this matter will be informed to the stock exchanges.
5. There is no other change in the disclosure previously disclosed to the stock exchanges.



These directions remain effective until the Commission issues an order permitting resumption of operations.
<b>iv</b>	Details of the violation(s)/contravention(s) committed or alleged to be committed;	The Commission has not specified any particular laws or regulations contravened by the Unit, except for a general reference to violations of Air Pollution control laws, rules, and regulations.
<b>v</b>	Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible.	<p>This manufacturing unit contributes about 3.5% of the Company's Standalone Revenue.</p> <p>The management has assessed the directions issued for the closure of the Unit due to the alleged violation of Air Pollution laws. Based on this assessment, the management does not anticipate any material adverse impact on the financial, operational, or other activities of the listed entity that can be quantified in monetary terms at this stage. The management is in the process of obtaining legal advice and has initiated actions to ensure compliance with the directives issued by the Commission to facilitate the resumption of the Unit's operations.</p>
